RE: General Election: Judicial Candidates

As you are aware, the California Constitution requires that all appointments and nominations to the courts of appeal by the Governor be confirmed or rejected by the Commission on Judicial Appointments (COJA).

On August 23, 2018, COJA held the confirmation hearings for four judicial appointees and nominees. All four were confirmed, immediately sworn into their respective offices, and will appear on the Certified List of Candidates for the November 6, 2018, General Election ballot.

For purposes of ballot layout, Elections Code section 13210(d) provides as follows:

In the case of candidates for Justice of the Supreme Court and court of appeal, within the rectangle provided for each candidate, and immediately above each candidate's name, there shall appear the following: "For (designation of judicial office)." There shall be as many of these headings as there are candidates for these judicial offices. No heading shall apply to more than one judicial office. Underneath each heading shall appear the words "Shall (title and name of Justice) be elected to the office for the term provided by law?"

For the justices who were confirmed by COJA on August 23, 2018, based on Elections Code section 13210(d), under the main "JUDICIAL" heading and specifically under the following headings, the ballot should read as follows:

- **For Associate Justice, Court of Appeal, First Appellate District, Division Four**

Shall Associate Justice Alison M. Tucher be elected to the office for the term provided by law?

- **For Associate Justice, Court of Appeal, Second Appellate District, Division Three**

Shall Associate Justice Halim Dhanidina be elected to the office for the term provided by law?

- **For Presiding Justice, Court of Appeal, Second Appellate District, Division Four**

Shall Presiding Justice Nora M. Manella be elected to the office for the term provided by law?

- **For Associate Justice, Court of Appeal, Second Appellate District, Division Five**

Shall Associate Justice Dorothy C. Kim be elected to the office for the term provided by law?

A number of counties have contacted our office regarding the names of the other judicial candidates who will appear on the November ballot. Please see the Judicial Candidates attachment for this information. The attachment includes the four above-named justices.
