RE: Initiative: #1936 Related to Minimum Wage – Eligibility for Ballot

Joe Sanberg, the proponent of RAISES MINIMUM WAGE. INITIATIVE STATUTE. (#1936), has filed more than 685,534 valid signatures with the counties.

Therefore, pursuant to Elections Code section 9033, the initiative measure is eligible for the November 5, 2024, General Election ballot and all further signature verification can be terminated.

On June 27, 2024, the Secretary of State will certify the initiative as qualified for the November 5, 2024, General Election ballot, unless withdrawn by the proponent prior to certification pursuant to Elections Code section 9604(b).
