RE: General Election: Public Notices Relating to Electioneering and the  
Corruption of the Voting Process

County elections officials are required to post notices regarding the prohibition of electioneering and the corruption of the voting process. (Elec. Code, §§ 18372, 18504.) These notices shall be posted on county elections officials' websites, and conspicuously at all buildings that contain a polling place (including an election official's office or a satellite location) and any outdoor site (including a curbside voting area and a vote-by-mail ballot drop box) at which a voter may cast or drop off a ballot. (Cal. Code Reg., tit. 2, §§ 20180, 20181.)

To assist counties with these posting requirements, the Secretary of State has created a combined poster that is available for counties to order. The 11" x 17" poster contains both notices and is available in English, Spanish, Chinese, Hindi, Japanese, Khmer, Korean, Tagalog, Thai, and Vietnamese. If your office would like to order copies of this poster, please complete the attached order form and submit to our office.

The Elections Division will use these submissions to determine the poster quantities for the November 8, 2022, General Election. County orders will be fulfilled once they are submitted to the Secretary of State and all printing is completed. Please submit your order form by **July 29, 2022**, to ensure accurate assessment of need. Orders submitted after this deadline will be subject to availability.
